Sub:- Estt-APREI Society (Regd), Hyderabad-Withdrawal of Special Officer postings-Orders-Issued-Regarding.

Ref:- Representation dated 20.01.2012 from the APREI Teachers' Association.

In view of pending regular promotion/appointment to the vacant posts of Principal, A.P.R.Schools, the willing P.G.Teachers of respective zones were posted temporarily as Special Officer against the vacant post of Principal, as a stop gap arrangement till such time regular arrangements are made. As it was a stopgap arrangement, seniority was not followed with a view to avoid transfer of persons from one institution to another in large numbers. The P.G. Teachers so posted as Special Officers were clearly informed that their posting as Special Officer is a stop gap arrangement and it will not confer any right and claim for their regular promotion/appointment to the post of Principal in future.

The willing PG Teachers so posted as Special Officer against the vacant post of Principals accepted the above conditions and joined the post.

Certain PG Teachers who were posted as Special Officers inspite of accepting the posting with the above conditions have approached the Hon'ble High Court for regular promotion to the post of Principal mere having discharging the duties of Principal. The Hon'ble High Court directed the Society to consider the cases of Petitioners as Principal. It is further found that such arrangement of Special Officers is leading to more legal complication. Further, there is no cadre as such of Special Officers in the Service rules of the Society. The APREI Teachers' Associations are also demanding for withdrawal of Special Officer Postings, and during the Coordination meeting with Service Associations held on 21.03.2011, the issue was discussed in detail and agreed to dispense with the system of posting Special Officers.

In view of the above, and to avoid further legal complications, and also to protect the seniority in the feeder category, the following orders are issued with immediate effect:-

The orders issued in respect of the following PG Teachers and Junior Lecturer as Special Officer against the post of Principal in their respective Institutions, are hereby withdrawn hereby and kept as Principal on Full Additional Charge from the date of issue of these orders against the post of Principal in their own scale of pay in which they are presently working.

They shall continue to work at the present places only and shall draw the salaries in the cadre of PGTs/JL from the provision of vacant post of PGT/JL/Principal in the same Institution.

From the date of these orders, they are eligible for charge allowance under the Provision of FR-49 as per rules, withdrawing the allowance of Rs.500/- Per Month paid till now:-
