The expenditure may be met from the available KGBV funds.

The following instructions have to be necessarily followed at the time of hiring of private vehicle.

1. The Private Vehicle, which are registered as a Taxi can only be hired for Govt. Duty
2. The Owner of the Vehicle hired for Govt duty should produce the pollution control certificate for every six months
3. The Owner of the Vehicle hired for Govt duty should produce the valid documents like permit, fitness certificate, insurance, tax etc., for plying for hire.
4. The Owner of the Vehicle hired for Govt duty should also produce the professional Driving License with badge of the Driver proposed to be engaged.
